

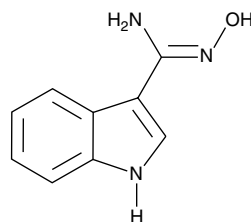

Indole-3-amidoxime

Applications

For long term storage, we suggest that indole-3-amidoxime be stored as supplied at -20°C. It should be stable for at least two years.

Indole-3-amidoxime is supplied as a crystalline solid. A stock solution may be made by dissolving the indole-3-amidoxime in an organic solvent purged with an inert gas. Indole-3-amidoxime is soluble in organic solvents such as DMSO and dimethyl formamide (DMF). The solubility of indole-3-amidoxime in DMSO is approximately 14 mg/ml and approximately 12.5 mg/ml in DMF.

Indole-3-amidoxime is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, indole-3-amidoxime should first be dissolved in DMSO and then diluted with the aqueous buffer of choice. Indole-3-amidoxime has a solubility of approximately 0.1 mg/ml in a 1:10 solution of DMSO:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Indole-3-amidoxime is a synthetic intermediate useful for pharmaceutical synthesis.
